

## Garden In A Box Winter Giveaway 2020

## **Rules and Regulations:**

- 1. **Eligibility:** This Campaign is open to residents of Colorado's Front Range due to necessity of retrieving the prizes in person.
- 2. **Agreement to Rules:** By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of [Giveaway Owner] as final and binding as it relates to the content of this Campaign.
- 3. **Campaign Period:** Entries will be accepted by submitting the Constant Contact Sign Up Form to receive updates about the 2021 garden season starting Nov. 12<sup>th</sup> 2020 and ending on Dec. 11<sup>th</sup>, 2020 at 12pm MST. All entries must be received by December 11<sup>th</sup>, 2020 at 12pm MST.
- 4. **How to Enter:** The Campaign must be entered by:
- A. Complete all required fields on our 2021 Sales Season Notification Form between Nov.  $12^{th}$  and Dec.  $11^{th}$  at 12pm MST.
- B. Our system captures the most recent time a single email address signed up on the form so each email address will only be entered in the giveaway once, regardless of the number of times you fill the form out.
- C. No purchase necessary.

The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Resource Central.
