The numbers reflected in Resource Central's 2025 Form 990 underscore the organization's resilience during a challenging economic year. Despite rising costs for insurance, utilities, healthcare, and other operational expenses, we are proud to have increased revenue, expanded support for our employees, and strengthened organizational reserves to sustain long-term impact.

Times like these require nonprofits to reflect carefully on past successes and challenges, evaluate the potential for future growth, and sometimes make difficult decisions in support of long-term stability. In 2025, we closed the chapter on our Renew Our Schools program after more than a decade of inspiring over 200,000 Colorado students to conserve energy. At the same time, our Board of Directors approved a new Strategic Plan that charts a path to **double** our conservation impact over the next five years.

Guided by our mission to empower people to live more sustainably and make conservation a way of life, Resource Central's resolve is stronger than ever—and demand for our affordable, easy conservation programs is higher than ever. Thanks to a partnership with the Colorado Water Conservation Board, we expanded water conservation programs like Garden In A Box and Lawn Replacement into communities across Colorado's Western Slope while increasing conservation resources available to Front Range residents. Support from private donors and the Colorado Department of Public Health and Environment also helped strengthen our Materials Reuse outreach efforts, contributing to a record 61,489 participants reusing building materials in 2025. In addition, our volunteer program generated 1,532 hours of service in support of our mission.

On behalf of our Board and staff, thank you to the individuals, partners, and communities across Colorado who continue to support and believe in our vision of a resilient, waterwise, and waste-free future.
